Open Government Partnership, Joe Powell, Deputy Chief Executive Officer



Joe Powell is the Deputy Chief Executive Officer of the Open Government Partnership (OGP). He leads OGP's global engagements, including working with the OGP Steering Committee, OGP Summits and linking OGP with other multilateral processes. He previously worked for the ONE Campaign, where he was managing ONE's global campaign for increased transparency in the extractive industries. As Senior Policy and Advocacy Manager at ONE, Joe also led global advocacy on the G20 and policy development for the 2013 G8. Prior to working at ONE Joe launched an online current affairs platform called 'Uganda Talks' for the Independent, a weekly East African news magazine, and worked for Action Aid Uganda. He studied at Makerere University. Joe holds a BA from the University of Cambridge.

Canada, Mark Levene, Senior Advisor, Open Government, Treasury Board of Canada Secretariat (TBS)



Mark Levene leads the international and intergovernmental group as part of the Government of Canada's open government team at the Treasury Board of Canada Secretariat. He leads the work on national and international open government issues, working with partners to advance and align open government reforms, including work to support Canada's participation in the Open Government Partnership. Mark has been working on open government since 2012. Prior to that, he worked on a variety of different projects at Canada's national archives, Library and Archives Canada, helping to make Canada' documentary heritage more accessible to citizens.

USA, Mary Beth Goodman, former OGP Country Lead for the US Government



Mary Beth Goodman is an international development and anticorruption policy expert who has worked with governments, civil society organizations, the private sector and international institutions to advance democracy, human rights and social justice.

She served as the Special Assistant to President Obama and Senior Director for Development, Democracy and Humanitarian Affairs at the White House, where she was responsible for advising the President and National Security Advisor on a wide range of issues. Ms. Goodman previously served as a U.S. diplomat including in a variety of overseas postings and in Washington, D.C. During her career, she developed and negotiated

economic, trade, extractives, energy, and infrastructure agreements and worked on a broad range of international economic and development issues.

Prior to that, Ms. Goodman practiced international trade law and worked as an attorney-advisor for U.S. Customs and Border Protection at the Department of Homeland Security. She participated in the negotiations of several free trade agreements and oversaw the implementation of preferential trade programs for Africa and the Caribbean. Ms. Goodman earned an L.L.M. in International & Comparative Law from Georgetown University Law Center, a Juris Doctor from Chicago-Kent College of Law, and a Bachelor of Arts from James Madison University. She is a member of the Council on Foreign Relations and a certified mediator in conflict resolution.
