


Webinar: e-Government & Identity Authentication

Liina Areng



assumed the duties of Head of International Relations at Estonian Information System Authority in March 2014. Prior to her current position, she coordinated NATO Cooperative Cyber Defense Centre of Excellence's (NATO CCDCOE) international affairs. She holds an honorary title of NATO CCD COE Ambassador. Between 1999 and 2012, she held different positions in Estonian Ministry of Defense. Her last appointment in the Ministry was Senior Cyber Security Adviser. During 2007—2010, Liina worked as Assistant Defense Counsellor at the Permanent Representation of Estonia to NATO. Her previous positions include Arms Control Adviser (2005—2007) and Chief Expert on Russia and the Commonwealth of Independent States in Defense Policy and Planning Department (2000—2005).

Born on the 28th of June 1977 in Tallinn, Estonia, she has studied at the Oslo University in Norway and St. Petersburg University in Russia, graduated at the University of Tartu in political science in 1999 and holds a Master's Degree in peace and conflict studies from the University of Jaumel in Spain. She has also worked as a research fellow in NATO Defense College and participated in various in-service trainings at the Swedish Defense College and NATO School in Oberammergau.

Jorge Alzamora Contreras



is the Chief of the Modernization and Digital Government Unit of the Ministry General Secretariat of the presidency of Chile. He was also previously a Municipal Administrator of the Municipality of Maipú; Chief of the Legislative and International Unit of the National Institute of Industrial Property; Director of Research, Development and Innovation of the Institute of Innovation in Mining and Metallurgy S.A., a subsidiary of Cadelco; and Director of the Innovation and Transferring of Technology of the Albagli and Zaliasnik study. As a professor he has taught

different areas of Law at the Andres Bello, Miguel Cervantes, San Sebastian and Adolfo Ibañez, universities. Jorge is an attorney of the Catholic University of Chile, and holds a Master degree in Law and Technologies from Ottawa University in Canada.
