If you are accepted to the course, you will automatically receive a US\$225 Grant over the total course value of US\$350.

About the Course

The course aims for participants to acquire and consolidate a solid knowledge of the main concepts, benefits and advantages of e-Government for improved administration and performance; as well as the fundamental elements that must be present in an e-Government strategy. The tools and knowledge acquired in this course will allow students to incorporate a global vision, around in-depth practical analysis of successful experiences in different countries.

How will the course be offered?

The course will be taught entirely online. During 7 weeks, each week will cover a module, which will begin with readings and online activities that are coordinated with the academic supervision of specialized tutors, who will support, guide and provide feedback to participants while they take an active role in the learning process. As part of the course, participants will develop a final project which aims to validate the knowledge gained in the course, usually resulting in the creation of a project proposal, which will address issues directly related to their work environment. The participant will have access to the tools in the virtual classroom, including chat, interactive forums and emails.

Certification: Only those participants who have satisfactorily completed the requirements of form, substance and procedure of the course, according to the final evaluation of the tutor, will receive a digital certificate of the OAS certifying their approval. **An additional shipping cost of US\$25.00 exists if a hard-copy certificate is desired.**

What are the expected results?

At the end of the course, participants are expected to have the necessary skills to be able to participate in the design of an e-Government strategy and, drawing heavily from the guidelines an analysis of experiences introduced in the course, adapt the strategy to the particular needs and challenges of their respective governments.





What should I do to take the course?

- 1. Register: Click here. Until 02 August
- 2. Wait for the registration results on 03 August. If you are accepted to the course you will receive payment instructions via email. Remember, if accepted, you automatically become the beneficiary of the OAS grant for US\$225 over the total value of the course US\$400, leaving the final cost per participant of US\$175.
- 3. Proceed to payment between August 3 and 20, equivalent to US\$175 after the OAS scholarship.
