# DESIGN AND IMPLEMENTATION OF E-GOVERNMENT STRATEGIES, EDITION #63













If you are chosen to participate in the course, you will automatically be awarded a partial scholarship from the OAS for \$225 on a total course value of \$400. For this reason you will only pay the amount of U\$ 175.



The objective of the course is that the participants acquire and consolidate an operational command of the main Concepts of Electronic Government, as well as of the critical elements that should integrate a strategy of this nature. Such command is possible through the: a) induction of a global vision on the development and implementation of projects of these characteristics, b) the analysis of successful experiences of various countries' Electronic Government, and c) the elaboration of a project by the participant on Electronic Government that fits the jurisdictional and territorial scope.

#### What is the course methodology?

The course will be completely online. During 7 weeks, a module will be developed each week, which will open with online lectures and activities coordinated with the academic supervision of specialized tutors, which will assist and guide the participants while these assume an active role in the learning process. As part of the course, the participant will elaborate a final assignment whose objective is for the participant to validate the knowledge gained through practice, generally resulting in the creation of a project proposal, engaging in topics directly related with their work surroundings. The participant will count with the tools of the Virtual Classroom, including chats, interactive forums, and emails.

**Certification:** Only those participants that have satisfactorily complied with the requirements of assistance, academic activities, and classroom participation, according to the final tutor evaluation, will receive a Digital Certificate of the OAS (SPA) accrediting their passing. **The mailing of the original certificate will have a cost of US\$25.00 dollars.** 

#### What are the expected results?

When finalizing the course, the participants will have the ability to work in the preparation of a strategy of Electronic Government, using the general guidelines foreseen, adapted to the needs and challenges present in each specific case.




