I. CASE SUMMARY

Victim(s): Sabino Díaz Osorio and Rodrigo Gómez Zamorano

Petitioner(s): Bárbara Zamora López, from the law firm Tierra y Libertad A.C.

Facts: On October 24, 1997, the Inter-American Commission on Human Rights received the petition filed by Bárbara Zamora López of the law firm *Bufete Jurídico Tierra y Libertad A.C.* representing the next-of-kin of Messrs. Sabino Díaz Osorio and Rodrigo Gómez Zamorano, alleging the international responsibility of the Mexican State for the events surrounding the alleged killing of Messrs. Sabino Díaz Osorio and Rodrigo Gómez Zamorano, who had presumably been killed by two individuals, Donaciano and Carmelo Tapia Mendoza, on July 15, 1992. Furthermore, the petitioners complained that the State had been negligent in conducting the investigation and their unjustified delay in administering justice.

Rights allegedly violated: The petitioners alleged that the Republic of Mexico violated the rights enshrined in Article 4 (right to life), Article 5 (personal integrity), Article 8 (fair trial), and 25 (judicial protection) of the American Convention on Human Rights.

II. PROCEDURAL ACTIVITY

1. The IACHR published the homologation report on August 17, 2020, declaring that the agreement has been fully complied with.

- The State provided Herlinda, Laura Abril, and Blanca Azucena Gómez Villegas with monetary compensation, as agreed upon.
