**Response:** 

The IACHR will take into account this recommendation. The Commission is committed to support local/ national human rights mechanisms, with particular emphasis in countries where democratic institutions are weak. As such, the IACHR will seek to reinforce the monitoring activities with this purpose.

For instance, during the preparation of country visits, the IACHR (and RELE) will continue to liaise with national human rights mechanisms, leveraging on their local networks, knowledge of the in-ground situation, and up to date information. Similarly, the IACHR and RELE will reach out to national human



rights mechanisms of countries with weak democratic institutions, to seek their participation in public hearings, meetings, or webinars, when possible and relevant.

In case of any specific actions and resources needed, the IACHR will reflect it in the realignment of the current grant.

**Response:** 

This recommendation is aligned with Strategic Objective 4 of the IACHR Strategic Plan and the ongoing IACHR/RELE work plan. The Commission will ensure further effort to promote joint initiatives and coordination with the UN human rights system.

So far, the IACHR and its RELE carry out joint work with UN agencies, regional offices and Special Procedures that have led to the production of joint press releases, letters to States, among other types of statements and working mechanisms. RELE for instance has experience in joint visits to States, joint amicus submitted to human rights national and international courts, joint declarations, among other joint mechanisms. Coordination with multilateral human rights initiatives have proved useful for both parties as they maximize benefits and strengthen the voice of human rights bodies among States and other actors.

#### **Response:**

The IACHR is starting the process of the design of the IACHR Strategic Plan 2022-2026. To this end, between June-July 2020, the IACHR launched the bidding process with the Department of Procurement (DPMO) of the OAS, to select the expert firm to facilitate the process. This is also part of output 5 (activity 5.1) of this new grant and part of the scope of the project.

The external evaluation of the Strategic Plan 2017-2021 were conducted from July to December 2021 which involved the consultation of all stakeholders, including the OAS Member States.

During the preparation of the new plan the IACHR will conduct an extensive consultation process that includes dialogues with Member States. This is an opportunity to promote a closer and trustful relationship.
